

This is your Arizona TAX CREDIT opportunity package

Your donation to Steps to Recovery Homes—up to \$800 if filing jointly or \$400 as an individual—can be directly deducted from the amount you owe in Arizona state income taxes. Anyone paying Arizona state taxes is eligible. This tax credit can be carried forward up to 5 years. You do not need to itemize deductions to qualify.

You can donate to more than one organization that qualifies for the Arizona Tax Credit. The credits are cumulative. Thus, two donations of \$400 each to two different organizations (joint return) will result in total credit of \$800. **Thank you for helping Steps to Recovery Homes.**
